BY THE END OF 2021 WE HAD ABOUT 10 SATELLITE LOCATIONS OPEN ACROSS THE VALLEY AND ALL OVER ARIZONA. THESE SATELLITES ARE HOSTED IN COMMUNITY SPACES SUCH AS YMCAS OR CHURCHES AND HOLD PROGRAMS ONE DAY A WEEK.
